#### 1. Terms for All Members

#### **Professional Conduct**

- You may NOT:

- Negotiate or act on behalf of the Club without prior written approval from a MENA Consultant-authorised signatory.

### **Sub-Groups & Events**

- Do NOT create any MC Club-branded sub-groups (e.g. WhatsApp, Slack, LinkedIn, or in-person gatherings) without prior written approval.

# **Platform Etiquette**

- All activity must comply with platform rules (LinkedIn, Slack, WhatsApp, etc.).
- Platform moderators reserve the right to admit, mute, or remove members who breach these terms.

### **Confidentiality & Intellectual Property**

- Club templates, reports, and exclusive content are for personal professional use only.
- Re-sharing beyond fair-use excerpts requires explicit consent from MC Club.

#### **Updates to Terms**

- MC Club may update these Terms and Conditions at any time.
- Continued participation in the Club constitutes acceptance of the most recent version.
